## **RELEASE OF LIABILITY FOR YOUTH SOCCER - PLEASE READ BEFORE SIGNING**

IN CONSIDERATION OF the child/adult named below being permitted to participate in activities and events under the jurisdiction of the Midland Soccer Club, the undersigned acknowledges, understands, and agrees to the following:

1. I understand the nature of youth soccer and that I am qualified, in good health and in proper physical condition to participate in youth soccer activities and events. I further agree and warrant that if, at any time, I am not in good health or proper physical condition, or believe conditions to be unsafe, I will immediately discontinue further participation.
2. The risk of injury and/or illness from activities involved in youth soccer is significant, including the potential for permanent paralysis and death; while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist.
3. The risk to have direct or indirect contact with individuals who have been exposed to or diagnosed with a communicable disease, including but not limited to COVID-19 or other medical conditions, diseases, maladies, or variations thereof, does exist and it is impossible to eliminate the risk that this child/adult could become infected through contact with or close proximity to an individual with a communicable disease.
4. These risks may be caused by my own actions or interactions, the actions or interactions of other participants or of the Releasees named below, and/or the conditions in which the youth soccer activities or events take place. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for this child/adult's participation in youth soccer.
5. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual, significant hazard during my presence at activities and/or events under the jurisdiction of the MSYSA, this child/adult will discontinue participation and bring such hazard to the attention of the nearest official immediately.
6. This child/adult, and on behalf of my/our heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE AND HOLD HARMLESS AND AGREE TO INDEMNIFY the Midland Soccer Club, their officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct youth soccer activities or events ("RELEASEES"), WITH RESPECT TO ALL LIABILITY, CLAIMS, DEMANDS ANY AND ALL ILLNESS, DISABILITY, DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, INCLUDING TO THIS CHILD/ADULT, to the fullest extent permitted by law arising from or caused by this child/adult's participation in the youth soccer activities or events.
7. Covid-19 Provision
  - a. I agree that I and all other participants and/or persons in my family involved in any way in the youth soccer activities or events will fully comply with all federal, state and local ordinances, codes, rules, regulation, executive and/or emergency orders, and to strictly follow the protocols given the applicable governmental authorities, arising from, addressing or related to Covid-19 and/or any other threats to public health.
  - b. I agree that the releases, waivers and indemnities set forth above apply equally to any and all claims, loss, cost, damage and/or expense arising from or related to my or any participants, spectator's, or other person's failure to comply therewith or otherwise related to exposure during or in connection with the permitted youth soccer activity or event.
  - c. I agree that effective physical distancing and proper hygiene can be only accomplished through personal responsibility and it is each person's individual duty to protect themselves, their families and community, and doing so is the sole responsibility of myself, participant (if other than me), the other participants, and the other parties involved in the youth soccer activities or events, not the responsibility of the Midland Soccer Club/
